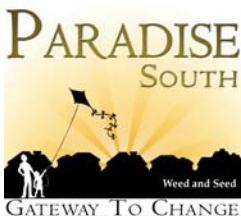

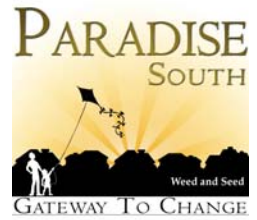

I am of legal age and am freely signing this agreement. I have read this from and understand by signing this form, I am giving up legal rights and remedies.
